Fire commissioners throughout Idaho are elected by the people in each fire district which total over 600 elected officials. Fire district commissioners are the one who are financially responsible for the fire district and administer and approve "ALL" policies, purchases, hiring/appointment of key employees (i.e. Fire chiefs) and most importantly that all state statutes/laws are followed within their respective districts.
