The Mountain Home Rural Fire District recently had a situation that brought to light the importance of rural fire protection.

A small subdivision just out of the fire district had a house fire. We were called to extinguish the fire. The home owner was told that they were out of the district and that we would not respond. This subdivision has been asked on several occasions to join our fire district and have declined. It is a shame that for the tax assessment of less that \$100.00 per year, these home owners would decline fire protection. The BLM was called in to protect their adjoining property and through mutual aid agreements paid us to come and protect other structures. There was only one structure lost in this case.

At our next Rural fire district meeting, a group of home owners from this subdivision approached us to join the fire district. It is unfortunate that there has to be a disaster for property owners to see the value in having fire protection.

We as rural fire commissioners should encourage property owners outside and adjacent to our districts to join and be protected by our Rural Fire Districts. No one wants to see a loss of property or life.

As the title would suggest, it is very important for our local fire stations to maintain a positive presence in each community they serve. Whether large or small, rural or city, 'neighborhood' stations should be filled with neighbors and friends or at least acquaintances. People who are known around and are friendly and, by the way, are willing to risk their lives for ours!!

Maybe Stations in small towns have an easier go of it being a 'presence' in an area where there is not so much 'presence' around. Like cities, but I think that even in a city there is still a neighborhood there, somewhere, maybe a lot of them. It just may be harder to define.

There are plenty of occasions for interaction. Perhaps a school nearby, or a youth center, or a church. Or how about a Fire Station??!! Everybody loves those. We work in one of the biggest attractions going!!

In Naples, ID, home of **South Boundary Fire Protection District (SBFPD)**, there is not so much 'presence'. We have a General Store/Post Office, a restaurant/bar, a saw mill, an elementary school, a cluster of homes and a Fire House. And more folks spread across the local country side.

When we put up a new station some years ago, it included a small kitchen and community room. It's good for firefighter's mtgs, commissioner's mtgs, CPR training, Friday Soup Kitchen, Naples Helping Hands, Food Bank on Thursdays, a weekly Martial Arts class, a weekly worship service, our yearly Christmas party and/or for just stopping in for a cup of coffee.

In the winter, next to the Station, the firefighters assemble an ice rink from bales of straw and a large tarp. Behind that we 'sell' Christmas trees for donations. Next door to the Station is Naples Elementary School, K-5. **SBFPD** is always a presence at fire drills and fire prevention classes. The fence between the two has a gate for emergency access, both ways!!

On the last half day of school we have what we used to call 'Field Day', like a giant recess!!! The PTA has activities for the kids, bounce houses, fun games, etc, and **SBFPD** had a truck and a tender set up for the kids to spray water, at each other and at targets. We also offer scholarship opportunities for college-bound seniors.

I could go on, but you get the idea. Not everything we do will work for everyone. But every area will have possibilities for 'community. Find out what yours are. It promotes good will, makes good friends **AND**... youngsters may grow up wanting to be FIREFIGHTERS again!!!
